## Flonivin® Boulardii, Capsules

# <u>Dietary product - Food for special medical purpose</u>

Flonivin® Boulardii, Capsules is food for special medical purpose containing 10 milliard of beneficial microbes called Saccharomyces boulardii, zinc and vitamin D3, intended for nutrition of persons with zinc deficiency, hypovitaminosis D, acute and traveller's diarrhoea, and antibiotic-induced diarrhoea, for use along with the standard treatment for Helicobacter pylori infection, in inflammatory bowel disease (Crohn's disease, ulcerative colitis) and irritable bowel syndrome, along with the treatment for Clostridium difficile infection, to help regulate the intestinal microflora, in persons with poor or impaired immunity and a tendency to frequent infection development, and in persons with other disorders and conditions requiring vitamin D3 and zinc replenishment.

### **Ingredients**

Saccharomyces boulardii, hydroxypropyl methylcellulose (thickening agent), zinc oxide, cholecalciferol, magnesium stearate (anticaking agent).

#### Use

Adults and children over 12 years of age: Take one capsule once daily with plenty of water, without chewing it.

## **Notes**

This product is nutritionally incomplete food and it is not suitable for use as a sole source of nutrition for its target population.

Keep out of the reach of children.

#### Warnings

The recommended daily dose should not be exceeded.

The product must not be used by persons allergic to any of its ingredients.

The product is not intended for children less than 12 years of age, persons suffering from gastric or duodenal ulcer, and persons with hypercalcaemia and hyperparathyroidism.

Persons treated with antimycotic agents should not take **Flonivin® Boulardii**, *capsules* because therapeutic effect might not be achieved.

Products with *Saccharomyces boulardii* are not recommended with immunocompromised persons, persons under immunosuppressant treatment, including patients with allograft, immediately after surgery, persons with bloody diarrhoea, and persons with central venous catheter.

Pregnant and nursing woman can use this product only if instructed to do so by their doctor.

Caution should be exercised with persons taking thiazides, cardiac glycosides, rifampicin, isoniazid, phenytoin and barbiturates.

Concurrent corticosteroids could result in reduced action of this product.

This product must be used under medical surveillance.

Not intended for parenteral use.

### **Storage conditions**

Store in the original package, protected from light and moisture, at temperatures up to 25°C.

#### Shelf life

Do not use after the expiry date stated on the pack.
