Food supplement

Beviplex® neuro, Tablets is a food supplement with alpha-lipoic acid, uridine phosphate, cytidine phosphate, and B vitamins, formulated to boost the nervous system, improve psychological functioning, and offer antioxidative protection.

Thiamine, niacin, and vitamins B2, B6 and B12 contribute to normal functioning of the nervous system. Thiamine, niacin, and vitamins B2 and B12 contribute to normal psychological functioning. Vitamin B2 helps to protect the cells from oxidative stress and maintain normal eyesight.

It is used as a food supplement for normal functioning of the nervous system and increased requirement for protection against oxidative stress. It helps to relieve pain and other nervous sensations like numbness, tingling, burning, and pins and needles.

Ingredients: Alpha-lipoic acid, microcrystalline cellulose (emulsifer), uridine 5'-monophosphate, polyvinylpyrrolidone (stabiliser), cross linked sodium carboxymethyl cellulose (bulking agent), nicotinamide, calcium silicate, talc and magnesium salts of fatty acids (anticaking agent), calcium D pantothenate, cytidine 5'-monophosphate, thiamine hydrochloride, riboflavin, pyridoxine hydrochloride, methylcobalamin.

Use:

Adults: Take 1 tablet once daily with some water.

Notes:

The recommended daily dose should not be exceeded. Dietary supplements should not be used as a replacement for a varied and balanced diet!
Keep out of the reach of children.

Warnings:

The product must not be used by persons allergic to any of its ingredients.
Not intended for pregnant or breast-feeding women and for children under 18 years of age unless recommended by the doctor.
Care should be taken in persons with diabetes.

Storage conditions:

Store in the original pack, in dry and dark place, at the temperatures up to 25°C.

Shelf life:

Do not use after the expiry date stated on the pack.
